Re:	Recording Fee Increase June 7, 2018

## Effective June 7, 2018

First page fee for *most* document types will be **\$99.00**, an increase of \$25

Please refer to the fee schedule on reverse for exception fees based on document type. The recording fee for additional pages beyond the first is \$1 per page.

Two separate pieces of legislation account for the \$25 increase, each raising surcharges for housing programs. Details of these legislative bills can be found at <u>www.leg.wa.gov</u>. Housing surcharges now total \$83 of the \$99 basic recording fee.

HB 1570, Increases the Homeless Surcharge by \$22

E2SHB 2578 Increases the Affordable Housing surcharge by \$3

Documents currently exempt from all or part of the housing surcharges will continue to be excluded from the same surcharges. This list includes Assignments of Deed of Trust, Appointments/Substitution of Trustee, Marriage, Death Certificates, and state/city/county liens and lien releases.

We are <u>unable to issue refunds</u> and are thus prevented from recording any documents arriving prior to June 7<sup>th</sup> accompanied by the new fee. All documents arriving in our office June 7<sup>th</sup> and later will require the new fee in order to be recorded, and any having insufficient fee will be returned unrecorded.

**Tip for submitting documents close to the effective date:** Customers may wish to include an extra \$25.00 check in addition to their check for current recording fees. If the document records prior to June 7th, we will return the unneeded check for \$25.
