All voter registration applications, transfers from another county, and changes of address within Chelan County, submitted by mail or online, must be postmarked by Monday, July 9, 2018 or may be delivered to the Chelan County Auditor's Office no later than 5:00 p.m., Friday, July 9, 2018 to be eligible for the August 7, 2018 Primary Special Election.

Persons not already registered in Washington State may register in-person no later than Monday, July 30, 2018 at the Chelan County Auditor's Office, 350 Orondo Ave Level 3, Wenatchee, Monday thru Friday, 9:00 a.m. – 5:00 p.m.
