Persons not already registered in Washington State may register in-person no later than Monday, October 30, 2017 at the Chelan County Auditor's Office, 350 Orondo Ave Suite 306 Level 3, Wenatchee, Monday thru Friday, 9:00 a.m. – 5:00 p.m.
