All voter registration applications, transfers from another county, and changes of address within Chelan County, submitted by mail or online, must be postmarked by Monday, January 16 or may be delivered to the Chelan County Auditor's Office no later than 5:00 p.m., Monday, January 16, 2017 to be eligible for the February 14, 2017 Special Election.

Persons not already registered in Washington State may register in-person no later than Monday, February 6, 2017 at the Chelan County Auditor's Office, 350 Orondo Ave Level 3, Wenatchee, Monday thru Friday, 9:00 a.m. – 5:00 p.m.
