RESOLUTION NO. 2018-____

A Resolution Establishing a Fee Schedule for the Fire Prevention and Investigation Department

WHEREAS, Resolution 2017-55, dated July 3, 2017, did establish a separate Chelan County Fire Prevention & Investigation Department so that the Fire Marshal would operate outside of the Community Development Department;

WHEREAS, pursuant to Chelan County Code (CCC) Chapter 3.24, fee for fire and life safety inspections are currently contained under a fee schedule for the Community Development Department;

WHEREAS, pursuant to CCC 3.24.010, the fee for the fire and life safety inspection program is currently set at \$25;

WHEREAS, the current fire and life safety inspection program allows for self-reporting;

WHEREAS, Chelan County will begin to require on-site fire and life safety inspections conducted by qualified inspectors in lieu of self-reporting;

WHEREAS, the current fee of \$25 is insufficient to defray the administrative costs of inspections and related expenses;

WHEREAS, the International Fire Code was amended on July 1, 2016 to require permits for the installation of underground supply piping for automatic sprinkler systems;

WHEREAS, permits for the installation of underground supply piping for automatic sprinkler systems will require at least two inspections conducted by qualified inspectors thereby adding additional administrative costs to issuance of such permits;

WHEREAS, the fees set forth in Exhibit A represent the costs of inspections and related administrative expenses;

NOW, THEREFORE BE IT HEREBY RESOLVED, by the Board of County Commissioners, Chelan County, that the amendments to the Chelan County Code contained in Exhibit A are adopted.

3.25.020 Administration of fee schedule.

No application will be considered complete and permit processing not commenced until the appropriate fees have been received. Fees required for planning review of permits and appeals of decisions in nonpermit services are payable prior to the services being rendered. Each action for which a fee is listed in CCC 3.25.010 will require a separate fee. Projects that involve a number of actions or permits will need to remit the total of the various fees before a determination of completeness is issued and processing begins.

3.25.030 Other fees.

Other fees required in conjunction with the above applications (i.e., taxes, recording fees, etc.) are not included.

3.25.040 Refund policy.

<u>Full or partial requests for refunds of application fees paid must be made in writing to the board of county commissioners. The board of county commissioners has the sole authority to approve or reject such requests.</u>
