B.2 SECTION 1-05.4(1)- Contractor Surveying and Tolerances

The first paragraph is revised to read: The Engineer or a representative of the Contracting Agency will establish the horizontal and vertical control network for this project for use by the Contractor. This will include staking the proposed roadway and stream alignments, which the Contractor will then use for construction of the project.
