

INVITATION TO BID

**Nason Creek Upper White Pine Project  
Stream Habitat Enhancement in Subreach 2**

Sealed bids will be received by Chelan County at the Board of County Commissioners Office, Chelan County Administration Building, 400 Douglas Street Suite 201, Wenatchee, Washington until MONDAY, APRIL 10, 2017 at 11:00 AM, and then and there publicly opened and read for:

Chelan County Natural Resource Project Nason Creek Upper White Pine Project, stream habitat enhancement in Subreach 2. This contract provides for the stream habitat enhancement work along Nason Creek at Upper White Pine Reach, Subreach 2 (River Mile 13.3 to 13.8). The work includes, but is not limited to: construction of a channel realignment, removing sections of levees, removing a blockage at a relic meander channel, installation of various large wood structures, placement of stream bed material; installation of fabric encapsulated soil (FES) lifts with plants, and placing fill along a section of main stem river to be abandoned. Additional work necessary for completion of this project includes: traffic control; protection of White Pine Road and culverts; erosion & sediment control; pollution control; access routes; clearing & grubbing; diversion, dewatering, coordination with fish rescue by others; excavation, haul, temporary stockpile and/or salvage of fine soils, river gravels and riprap; import of stone products; and, temporary bridge crossing of Nason Creek, and other work as identified on the Contract Plans. All work shall be in accordance with the attached Contract Plans, these Contract Provisions, the 2016 Standard Specifications for Road, Bridge and Municipal Construction, State of Washington, Department of Transportation, and addenda thereto.

A mandatory Pre-Bid site walk through with representatives from the Contracting Agency will be held on FRIDAY, MARCH 31, 2017 at 10:00 AM. Attendees should meet on USFS Road 6950 (Upper White Pine Road) approximately 200-feet from the intersection with US Highway 2. USFS Road is approximately 1,500-feet west of the Ray Rock Springs Custom Knives shop at 19475 US-2 Leavenworth, WA. A minimum of one representative from each Prime Contractor that intends to submit a bid is required to attend. The Contracting Agency will disregard any bid submitted from a Prime Contractor that did not have a representative attend the Pre-Bid site walk through.

A bid bond in the amount of 5% of the bid shall accompany all bids.
