

RESOLUTION NO. 2015- 90

RE: Amend Resolution No. 2015-81 Area and County Road Restrictions and Road Closures

WHEREAS, the Board of Chelan County Commissioners are authorized based on the recommendation of the Fire Advisory Board, to officially determine and publicly announce when any area or County Roads shall be designated as a high fire danger area, taking into account the need to prevent the occurrence of fires which might be caused by recreational, residential, commercial, industrial, and other activities, and

WHEREAS, the Board of Chelan County Commissioners adopted Resolution No. 2015-54 on May 18, 2015 declaring that the High Fire Danger Areas and County Road Restrictions be posted at a Level 2 Designation for Road Travel Restrictions, and

WHEREAS, the Board of Chelan County Commissioners adopted Resolution No. 2015-62 on June 29, 2015 declaring that the High Fire Danger Areas and County Road Restrictions be posted at a Level 2 Designation and imposed a Level 3 Designation for Road Travel Restrictions on Burch Mountain and Horselake Road, and

WHEREAS, the Board of Chelan County Commissioners adopted Resolution No. 2015-81 on August 25, 2015 declaring that the High Fire Danger Areas and County Road Restrictions be posted at a Level 3 Designation for Road Travel Restrictions, and

WHEREAS, the Fire Advisory Board has reviewed the current and forecasted conditions within Chelan County, and recommends that the High Fire Danger Areas and County Road Restrictions remain posted at Level 1 and Level 2 Designation for Road Travel Restrictions as shown on the attached Exhibit A.

NOW, THEREFORE BE IT RESOLVED, that the Board of Chelan County Commissioners will terminate Level 3 Road Travel Restrictions, while Level 1 and Level 2 Designations for Road Travel Restrictions will remain posted and be enforced throughout the unincorporated areas of Chelan County as identified in Exhibit A, as follows:

LEVEL 1 – AREA ACTIVITY RESTRICTIONS INCLUDE:

- No Fireworks
- No open flames devices
- No motor vehicles off the roadway
- No outdoor fires except for recreational residential campfires burning in a campfire area installed in accordance with the Chelan County fire advisory board guidelines. “Campfire area” is an outdoor fire burning area for recreational fires where natural wood materials other than rubbish can be burned. The campfire area must have all combustible material removed down to mineral soil and shall have a containment area of either rock, metal, concrete or any other noncombustible material and shall not be more than thirty-six inches in diameter. All combustible material one and one-half feet surrounding the camp fire area shall be removed. Fuel for the recreational residential campfire shall not extend above the edge of the camp fire containment area;

- Portable fireplaces/pits/chimeneas are approved providing they are placed on noncombustible material or all noncombustible material is removed to mineral soil with all combustible material one and one-half feet around the portable fireplace/pit/chimenea removed. Only natural wood materials shall be burned in the portable fireplace/pit/chimenea and the fuel shall not extend outside the portable fireplace/pit/chimenea.

LEVEL 2 – TRAVEL RESTRICTIONS INCLUDED:

- Restricts travel on County road; except for residents of the area and travel through the area to open public lands for legitimate purposes.

BE IT FURTHER RESOLVED that the notice of restrictions as identified in Exhibit A, will remain so until September 30, 2015.



Area Restrictions: Any open burning, outdoor fires, and use or operation of any equipment or open flame device liable to start fires; and no motorized vehicles allowed off the road; and prohibits the use of fireworks.

Travel Restrictions: Restricts travel on county road; except for residents of the area and travel through the area to open public lands for legitimate purposes.

Road Closures: Prohibits travel on county road; except for residents or designee approved by Sheriff who are actively involved in defense or evacuation of their property.
