I, the undersigned permittee or agent thereof, certify that the information shown hereon is known by me and is true and surest and understand that the permittee shall be liable as set forth in R.C.W. 46.44.110 for all damages to any county highway, bridge or elevated structure, resulting from the movement of equipment authorized by this permit on public highways of this county. The permittee shall further hold blameless, harmless and indemnity the county, the officers, agents and employees against any accident, liability, lose, injury, seller, and the costs thereof arising from the conduct or operations of the permittee in connection with this permit. I further understand that prior to movement the permittee shall establish a routing to safely detour all structures having a limited clearance less than the permitted height. If permit is changed, I authorize billing to the firm named.

This permit is only valid for county roads within Chelan County. Additional permits required for operation on State and other local jurisdictional roadways.
