Comprehensive Plan Amendments City of Leavenworth.

Transmittal of Recommendation from Chelan County Planning Department from continued public hearing held on December 18, 2001 addressing item #6 of the City of Leavenworth's 2001 Comprehensive Plan Amendments. Christy Osborne, representing the City of Leavenworth present for hearing.

The recommendation by staff is to adopt the modified City of Leavenworth 2001 Comprehensive Plan Amendments as shown in the Supplemental Staff Report, based upon the Findings of Fact and Conclusions as shown in the Addendum #1 of the Supplemental Staff Report that was submitted to the Board of Chelan County Commissioners on December 18, 2001.

Moved by Commissioner Hunter to adopt the Comp Plan with the exception of item 6 which will be remanded back to Planning Staff. Motion fails due to lack of second.

Discussions again open. It was determined that Christy Osborne is legally empowered by City of Leavenworth to agree to change in document language.

On item #6 the new language would read:

the area within the UGA identified on the land use map as 20,000 square foot minimum lot size shall be required to develop to the improvement standard adopted by the City for right of way, street improvements, domestic water and sidewalks in recognition that these areas may be further divided in the future. Septic systems shall be allowed upon approval by the Chelan-Douglas Health District. The shadow platting shall identify utility and right of way easements as required.

With this wording it was **moved** by Commissioner Hunter, seconded by Commissioner Hawkins and carried that the Board adopt **Resolution No. 2002-37** based upon findings of fact and recommendation of staff.

ITEM NO. 2 Public Hearing:

City of Leavenworth's 2001 Development Regulation Amendments.

The recommendation by staff is to deny the comprehensive plan map amendment.

After testimony from both staff and Mr. Jones, it was **moved** by Commissioner Hunter, seconded by Commissioner Hawkins and carried that the Board follow recommendation of staff to deny the comp plan map amendment. It was noted by Commissioner Walter that other means of dividing this property should be researched and a mechanism in place so that Mr. Jones can have two separate parcels and would not be damaged by a situation not of his doing. It was recommended that Mr. Jones and the Chelan County Building/Planning Department continue to work together to find a plan for resolution to this matter. It was acknowledged that the non conforming use plans are old and restrictive. There is need for more flexibility for new restrictions.
