- **11:30 A.M.** Commissioner Hawkins opens public hearing on petition for formation of Lake Wenatchee Water District. Attorney for the proponents Chuck Zimmerman opens with description of process. Correspondence from Klev Schoening and Bruce Bendickson; Gerald Becker; Charles Ferrel; and Craig Johnson presented into record.
 - Dwight Burke speaks opposing the configuration of the petition and suggests that discussions be held with the other water district.
 - Martha Steinborn offers no opposition to the water district but is opposing the subsidy or the initial assessment and favors exclusion of those owners that do not want it.
 - Morey Grosse does not wish to be included in the district. She believes it is stated that a property owner must gain benefit and she does not feel she will receive services.
 - Rollie Schmitten offers concerns regarding lack of knowledge of the plans and goals of the proposed district, but feels that a consolidation of districts may be of benefit to those involved.
 - Dave Leonard feels the majority of property owners are in favor of the formation of the district due to concerns about the quality of water and that there is a need for long term safe drinking water and also for fire protection. Eight additional non-voting petitions are presented

 - Commissioner Goehner asks if the PUD has been approached about the possibility of their involvement. Mr. Zimmerman does not believe they have interest in involvement in such a district due to the feeling that it would not be cost effective for the PUD. Mr. Burke also does not believe the PUD would want to take this project on. Mr. Bruce Bendickson informs the Board that the PUD formed the Alpine Water District.
 - Mr. Chuck Ferrel is not aware of current water quality and quantity issues but feels that the formation of a water district would be similar to an insurance policy.

- Sharen Jones of the Lake Wenatchee Mountain Water System is concerned about alternatives if the current aged system fails and also states that citizens pay for other community needs and services such as schools and hospitals even if they do not use the service.
- Morey Grosse relays that those owners that have their own systems would not be required to hook up but would pay the original assessment.
- Attorney Chuck Zimmerman reiterates that owners cannot be charged for stand by water systems and that there is only one statutory requirement for payment. That would be by vote and if the fee is not approved by vote, the users would be obligated to pay a higher fee. But, if you do not pay the fee now and request hook up later, you will have to pay more at that time.

Moved** by Commissioner Walter, seconded by Commissioner Goehner, and carried that because the three criteria for formation have been met, the Board directs staff to prepare a resolution for approval January 30, 2006, to forward this resolution to the Auditor for formal vote for formation of the Lake Wenatchee Water District which excludes the subdivision known as Telemark Lane. and Northshore Estates.
