- 2:08 P.M. Dick Griffin, the applicant speaks to the issues raised by the surrounding neighbors. He states that the Campfires are designated in the campground and are part of the experience. He also has noticed smoke from chimneys. He reassures the Commissioners that his family lives at Blu Shastin and manages the property. Mr. Griffin informs the Board that the Campground was sold to him with 91 sites. They have reduced that number to 86 sites. He states they do not allow campers' dogs to bark continually and have asked campers to leave if this is not adhered to. The Sheriff's Department has investigated the complaints and found the barking dog to be in the Valley Hi area, not the camp. He states resident children have stolen items from his property and he wonders if these are the same children that the Valley Hi residents are complaining about rocks being thrown. Mr. Griffin reiterates that he has no plans to increase the park but rather decrease the sites in the park. Improvements were made according to the regulations of the Spokane Health Department but due to the length of

time completing the regulations, such as upgrading the well and drain field, the permits were denied. Quiet hours are enforced according to Mr. Griffin. The request to move from rural to commercial designation is not to expand, but to place more space in between sites, offer washing machine service outside of its current location, and to carry and sell motor home and camping equipment and supplies. This would improve his campground ratings.
