- **9:44 A.M.** Property Developer Al Lorenz is concerned that the property he is developing does not have tangible benefit from storm water system and he is paying for access to a road other than the Knowles Road access.
- **9:53 A.M.** Scott Blaesing outlines the benefit of the joint efforts which are not visible.
- **9:53 A.M.** Al Lorenz states that he has been through the conditions of approval and shares his concern that new requirements should not be placed on his construction already underway. He does not believe any runoff will occur on his property from Knowles Road.

Mr. Jessup shares concerns that his development has storm water control and questions the benefit of this project for him.

#### NOON

**1:28 P.M.** Forest Supervisor Jim Boynton Present to Discuss Lake Wenatchee Ranger Station. Other Forest Service personnel present are Karen Molander and Paul Hart. Gordon Congdon of the Chelan Douglas Land Trust is also in attendance.

Commissioner Hawkins voices concerns over the recent decision by the USFS not to sell the Lake Wenatchee Forest Service property. He states that in the last three years the county has been involved in dialogue regarding public lands, the Lake Wenatchee property was used as an example of land that would be used for public and private mix and the acquisition of property for private use. Gordon Congdon also agrees that this property was discussed in the land trade meetings.

Mr. Boynton understands this issue has been a major concern of the county as well as the volume of acreage for the national forest. He believes, however, the Lake Wenatchee property was not a part of the land exchange base. He does not feel that selling the property was the best use of the land and the contiguous nature or for the values of the wildlife and habitat. The property will be slowly returned to a forested environment with the buildings set for demolition.

Commissioner Goehner questions the decision to remove the buildings when they could be used by other entities, and if the Forest Service will be building an administration building as planned. Mr. Boynton replies that the USFS will be adding an administration building on an identified site.

Mr. Boynton states that the Forest Service has heard the needs of the County and is still open to further discussion.

Mr. Congdon comments on the process and that the leaders of various agencies have the chance to talk with each other and the ability to surplus land may be less difficult with some agencies or land trades as options.

Commissioner Goehner clarifies that our goal is to preserve the critical lands for habitat and are offering incentives to preserve them. Commissioner Hawkins states that this was an opportunity to convert land from the Forest Service to private ownership in which restrictions could be placed so that the purchase did not interfere with the Forest Service mission. Commissioner Goehner states that he respects the Forest Service decisions but feels this was the only opportunity that was available in Chelan County.

Gordon Congdon asks if third party exchanges are feasible for other properties and Mr. Boynton replies in the affirmative. Mr. Congdon offers various other land trust resources be committed to research the subject.
