Commissioner Hawkins opens public hearing. Present representing the Grant County PUD are Sheryl Dotson and Stephen Brown. The requested vacation is in the Cascade Gardens area. County Engineer Greg Pezoldt states that this vacation is not as straight forward as a vacation for a road because this is not being requested for a road but for another purpose. RCW requirements do not allow vacations of right of way that leads to a waterway, except under certain, limited conditions.

Legal opinion was obtained by both Counsels for Grant County as well as for Chelan County. There are some legal interpretations that this vacation can be legally granted but it is of the opinion from Counsel from Chelan County that Chelan County is not required to grant the request.

Commissioner Walter voices concerns that there is no scientific evidence this project if the vacation is granted, a fish hatchery as mitigation for the Priest River Dam, may not be of benefit but rather may harm the fish runs. Commissioner Walter would require more documentation and a legal determination by NOAA Fisheries and that Grant County would maintain the access to Nason Creek.

Grant County representatives state the information is being gathered at this time. It is **consensus** of the Board to continue this hearing to a date uncertain to obtain the requirements as outlined above. Hearing continued.
