### 2:00:26 PM Malaga Water District Annexation (Continued) Hearing

Hearing opened by Commissioner Goehner. See attendance Sheet. Deputy Prosecuting Attorney Susan Hinkle gives status report. Chelan County has not received any further information from the Washington State Department of Health, who is the water service plan permitting agency, since the last hearing. The State of Washington has not been forthcoming with any information because the State of Washington has not received the information they maintain they require from the applicant, the Malaga Water District. The Malaga Water District's only request is to amend the boundaries of the district only, but not to amend their service system plan or capacity of their system. The Malaga Water District, therefore, does not believe they need to file an application with the State Department of Health. The District also believes that once the boundary is changed, a resident or landowner within that District would then apply for service and then the service area would be addressed.

Chelan County Planner Nathan Pate states that a boundary area change would not have the same response for significant issues by the Community Development Department of Chelan County as if it was a service area or capacity issue. The issue presented by the Malaga Water District is to separate the issues of changing service area boundaries as well as the

jurisdictional boundary which is not typically the case. Boundary jurisdiction is not directly related to the Growth Management Act.

Attorney for the District, Mark Peterson states that the Chelan County PUD District Area is by legal boundary not service area.

Dave Johnson of the Chelan County PUD states that the PUD is part of a regional water system which is a six year plan under a comprehensive plan what was developed in 2004. That plan has future boundary area defined in the regional water system. The parcels in question lay within that future area which mean they are in the PUD Water Service Area and which define the future and placement use of the water lines.

Mark Peterson states that inclusion in the PUD water service area may mean an overlap of the areas.

Commissioner Hawkins states that the original request was for the Gates property for an annexation by the Malaga Water District but in fact we are now talking about a change in the boundary. Therefore, the question would be: does a change in the boundary require action by the County Commissioners?

Attorney Hinkle states that yes, it would require action by the County Commissioners under RCW57.02 and subsequent sections. The Malaga Water District however, is contending the boundary can be changed without changing the service district which cannot be supported by the WACs. Attorney Hinkle also states that comments in the statutes which are not explicit in this issue would best be served and beneficial to all the parties to obtain an AG's opinion. If the three entities, Chelan County, the Malaga Water District, and the PUD request an opinion to clarify the issue for all parties and set a precedent for an issue the Community Development Department has never had before it in the past.

She further states the Malaga Water District is asking to expand and change their legal authority without any change in physical substance. She does not feel this action is not clearly supported by the Statute.

Attorney Peterson shares that the PUD now encompasses most if not all of the Malaga Water District, so if the county tries to parcel out which service area is served where, the PUD will have to divest itself of a huge service area and he does not feel that is a good result for anyone. This is not a service area boundary question, but rather a boundary question for three parcels, which would then support any future LID assessment to move forward. The Malaga Water District does not believe they are obligated to submit this to the DOH because it is an annexation.

Attorney Hinkle further adds that the statute allows the Commissioners to rule on the annex, but the Commissioners must determine if the proposed action is in compliance with the

Development Program Comprehensive Plan for water and sewage facilities. 57.02.040 criteria suggests and requires a service plan amendment to create a comprehensive plan section that is consistent with an annexation request.

Dave Johnson of the Chelan County PUD states that RCW 57.02.040 applies to water districts and it states that annexation requires municipal corporations must be approved by both boards, the Malaga Water District and the PUD Commission Board. The PUD has not been presented the application before their board or approved the annexation.

### 2:23:58 PM PUBLIC COMMENT:

Mr. Herb Gardner states that the DOH response to him was that the DOH has minimal involvement. He also states that a change of water system plan may be applied after an annexation. Mr. Gardner shares that the Water District has held its Annexation Hearing and has approved the annexation.

Mr. Rich Cole offers these points:

- If the boundary is extended the property is then in the PUD jurisdiction
- A list of participants of the petition was not provided and how many of those involved know they will be in an LID
- This is to the benefit of one developer alone
- Annexation was what was advertised, not another type of hearing
- PUD has no water system to Malaga
- The meeting was poorly advertised

Mr. George Spear speaks on the issue sharing that the land owner wants to develop and needs water and the water district has the water to sell him. He shares frustration on the process.

Attorney Peterson shares that this is consistent with the plan and wonders why is the PUD opposing the annexation. They have not supported their opposition with any legal information.

Dave Johnson states that 57.02.040 deals with annexation and also refers to 57.24.210

Attorney Hinkle states that at this time Chelan County does not have a report or recommendation from the DHO showing that we can approve this according to the criteria as set forth in the code. There needs to be consistency with all these plans for approval and it appears as though an Attorney General opinion may show that. A process that brings a level of understanding must be met in this matter before any discussion can be reached.

Timelines for an AG response are discussed. It is suggested by Attorney Hinkle that participants meet to come up with a format for discussion and possible solutions.
