2:46:07 PM PUBLIC HEARING – Petition for Form Columbia Shores Water District

Hearing opened by Commissioner Goehner. Present are Planners Matt Hansen and Graham Simon, Counsel Susan Hinkle, Community Development Director John Guenther, Attorney for the Petitioner Mark Peterson. See also attendance sheet.

Planner Hansen outlines staff report beginning with description of the proposed district. A new boundary description was submitted by the attorney for the petitioner. Mr. Peterson outlines the changes in the property description. Mr. Peterson states the only properties requested to be in the proposed district are owned by Premium Development or are under contract with Premium Developments. Jim and Barb Small are present and confirm their property to be excepted out.

Planner Hansen continues to outline the staff report. The Washington State Department of Health has been contacted as well as the Washington State Department of Ecology. The Department of Health states that they have no problem with the application to this point. The Department of Ecology shows issues with water rights and has reversed the decision made by the Water Conservancy Board due to the issues of water rights. No public comment has been received. Based upon the application information, the application may not be in compliance with the development program outlined in the county comprehensive plan. The Department of Ecology has requested more information on water rights from the applicant.

Counsel Hinkle speaks on RCW 57.02.010 (4) regarding the petition and the requirement of an excerpt from the bylaws as well as a notarized signature on the petition. There has been no submission of excerpt of bylaws or adequate signature.

Mr. White is not a registered voter in Chelan County to verify signature.

RCW 70.119(a)060 outlines the conditions for approval of creations of new water systems in a "group A" classification subdivision regarding management and financial resources for safe and reliable service. There needs to be evidence that there are sufficient means to provide safe, reliable, and consistent service in order to implement a federal mandate in addition to

state law. Given that the Department of Ecology has contested the existence of the water rights claim, these questions cannot be resolved easily.

Commissioner Walter questions the typical scenario of a home owners' association formation. Counsel Hinkle states the petition and application cannot meet the terms of RCW 70.119(a)060. There is no evidence of continuous, reliable and safe supply of water if they do not even have water rights. This is also a petition for formation where there are no residents in the predominant geography involved. This is a premature petition.

Commissioner Goehner requests information on RCW 57.04.140 on formation and dissolution and alternative methods for development of a new district that does not have any residents. This section also references a couple of other statutes that also need compliance as stated by Counsel Hinkle. The applicant is required to submit a "group A" public water system plan approval letter from the State Department of Health prior to plat approval. Counsel Hinkle feels this section is speaking in regard to final plat approval but does not require formation of its own water district. This can be done by the PUD or some other means but does not need to be by the formation of its own independent water district. The PUD maintains that the applicant receive favorable opinion from the PUD as to formation of the new district, also required by RCW 70.119(a).

Mark Peterson speaks on behalf of the applicant. He questions the report from the staff and the prosecutor letter on the water rights and claims. Counsel Hinkle notes that the Department of Health is the lead agency in this matter and any staff report by the Planning Department is a courtesy report with what information they have at the time. There will be other issues that come up and they will be addressed when that information is given to us. Mr. Peterson questions if the Department of Ecology commented on the approval of the water right change to certificate 23434. Planner Hansen states he has not seen that information. Mr. Peterson states he was not aware that this information was need today since he only has been notified minutes prior to the hearing.

Commissioner Hawkins notes the information that has been coming in all day and even at the opening of the hearing by the applicant themselves. There have been many changes.

Mr. Peterson states there are three criteria in which the application is to be judged and that is whether the application is in compliance with the comprehensive plan or basin wide sewage plan or the other under RCW 57.02.040. He states that water availability is a distant and unrelated issue. The signature issue is one that can be resolved by the applicant who is here. He is authorized as a representative of Premium Developments as owner of more than 60% of the land described.

Attorney Peterson states that a previous meeting was held with the PUD regarding other applications. He also states that Attorney Hinkle was present when he asked the PUD if they

could see any issues with the formation of this district and that they replied there were no problems.

Mr. Peterson goes on to say that as far as financial resources, that is required to be shown in the water plan. That plan has a financial section to it in which the financial aspect is discussed. Financial responsibility of the district formation is discussed in reference to not having the financial assurance prior to forming the district. Mr. Peterson says the process is done this way prior to having the corporation in existence because you cannot transfer assets to it until after formation. However, Counsel Hinkle states that the very product that is provided by the district is not owned or have ownership settled.

The attorney for the applicant states he has formed 7 water districts and three by this developer petition process. They are invariably formed with nothing because they cannot have assets transferred to them prior to their formation. They do not exist as a legal entity. The creation of the district is defining a service area but not necessarily defining where the water is coming from. The legal boundary of the water district shows the boundary of where and whom votes, etc. The service area is encompassed in the area and the service is determined at a later date. They still have to obtain a water plan approval with the financial and the ability to supply the water. He is requesting the ability to change the boundary description area.

Commissioner Walter speaks on the signature issue needed to clear up the signature of ownership verification.

Mr. Calvin White, owner, speaks on the signature issue. He feels that real estate contracts that have been notarized and would be on file in the County. He states that as far as the process he needs to form the district first. He has filed the water system plan with the Department of Health and is in the process and here to form the district, the first step to take.

Counsel Hinkle states that the burden of proof is on the applicant not the County. He has had a copy of a document from the DOE and he did not supply that information to us. Mr. Hansen produced information as soon as possible that came to him late and did not withhold information. There is also no requirement in the statutes as this application stands, but on other methods of formation. More discussion follows on conversations that were held at the PUD with Ms. Hinkle present. She does not recall that conversation with the PUD in respect to this application and states that others whom were present at the meeting do not recall that conversation as well.

Pat Aylward is present to reflect the correct legal description for the Small family property that is to be excluded from this petition for the three descriptions.

Commissioner Hawkins relates concerns about process and the many changes up until the hearing.
