This proposed road vacation is for a portion of road right of way and has been examined by the County Engineer and legal notice was provided. Access to the private property will not be affected. It appears that a deed signed by Coffin Brothers, Inc. in 1950 had a provision that Chelan County would vacate all the portions of the right of way but was not completed and no records were located. No one from public speaks on the matter.

County Engineer offers staff report. Petition was filed for Crown Estates by Ronald Crouse. A petition and bond was received on July 3, 2006 requesting the establishment of a 60' county road right of way. The County Engineer examined the petition and due legal notice was provided. An internal subdivision road will provide direct lot access from the stem. The County will not benefit by owning this right of way and would not be a benefit to the county road system.

9:58:05 AM Public Testimony Begins:

Dennis Webb who currently maintains the road speaks in favor of the project. He would like to see weed spraying and plowing of this road by the County. Commissioner Hawkins states the road would have to brought to County Road standards before the County would accept the road

into the road district. A road district could be established by the residents on the road. They are looking for some relief for weed spray and maintenance such as snow plowing.

Commissioner Walter asks if we accept the road establishment and require the improvements and standards, would the County be involved in the RID? That would be breaking new ground according to the County Engineer but we would not be a financial participant other than a pass through entity.

Earl Meyer speaks on the intent of the group to have an RID for the area. He states that in response to the comment that there is no benefit to the county road system, they are a part of the county. They are interested in paying for the relief in the maintenance working through the county. He would like to see this taken over by the county and assessed through the county.

Commissioner Hawkins says this is a testimony to why private roads need to be made to county road standards because at a later date it is difficult to maintain and the county is asked to come in and assume the road into the county system. Commissioner Goehner states that the county is held to higher standards than a private road as far as liability.

Herb Gardner states as a representative of the Malaga Water District he is here to support the County taking over this road to ease in their efforts regarding easements.

Discussion on the motion continues with Mr. Calvin White stating that Mr. and Mrs. Bell would not be included therefore the resolution with the legal description before this board would be corrected. Commissioner Walter asks about the criteria needed to be in compliance with the RCW. The criteria to be met are as follows: (1) whether the request for the proposed action is in compliance with the development program in the area comp plan; (2) whether the proposed action is in compliance with the basin wide water and or sewage plan as approved by the Department of Ecology and the State Department of Social and Health Services; and (3) whether the proposed action is in compliance with the polices expressed in the county plan for water and sewer facilities. There are no issues in reference to the community utilities according to the Development Director. The Department of Ecology has given their opinion which was in the file last week in which there are water issues that they recommend correction in their letter. Compliance definitions and issues are discussed. Development Planning Director John Guenther states the application is not in compliance with the Department of Ecology requirements. There are no county wide utilities requirements to be met. The Water and sewer facilities have not been addressed but this Board understands there are issues with DOE and compliance. The applicants were to provide the indication that the area had to be defined, which is still up in the air, and that the majority of land owners of the area had to be party to the application and any conflicting or overlapping service areas be determined as a part of the establishment of the district. He feels other things can come later as a part of the Department of Ecology required waters supply. Commissioner Hawkins reminds the Board that if we deny this application at this point it would not preclude them from bringing this application forward when it is complete. He also reminds the Board that a request was made at the hearing last week to continue the hearing to allow the applicant a one time opportunity to get the necessary information to this board. Commissioner Hawkins feels he is not in favor of taking action on something that is not clear, is incomplete and not properly supported.

Mr. Guenther also shares with the Board that the County is not the lead agency and therefore cannot coordinate the hearing as they would normally. Commissioner Walter agrees that the information and legal description before this Board has been a moving target. Mr. Guenther understands that the water right does not have to be perfected at the time of the formation. Commissioner Walter feels the homework should have been done by the applicant. He prefers to continue the hearing to allow the applicant to do that. This commission should not be expected to sit down and digest large amounts of information just prior to a hearing and decision based upon that new information.

The Board approves the motion to deny the petition for the formation of Columbia Shores Water District. Commissioner Goehner and Commissioner Hawkins vote to deny the application. Commissioner Walter votes against the motion. The application petition to form the Columbia Water District is denied. (**Filed** staff report and correspondence regarding water district proposal.
