# 8:30 A.M. Dispute Resolution Center Presentation to Board

Board Members and Interested Parties Present are TJ Farrell, Lynn Yialelis, Mike Kaputa, Kip Johnson, Alicia McRae, Sandy Harrison, Vicky Visculgia, Albert Rookord, Judy Hesburn, Concie Luna, John Brett, Judge Nancy Harmon, Judge Alicia Nakata, and Chuck Moser.

Discussion includes the benefits of dispute resolution, the possible users of the Dispute Resolution Center, the current constraints, sources of funding, and the sources and uses of funds for 2008-09. The proposal by the DRC Board is to approve an increase in the District Court filing fee increases adding \$15 surcharge to small claims fees and adding \$10 surcharge to civil fees as a two year pilot program.

Vicky Visculgia speaks for Olympic Credit Services of Yakima and their experience with DRC; one meeting in her ten years experience. Albert Rookord of the Armada Corporation also questions the DRC as an association. It is his belief that the Armada Corporation is in the business of dispute resolution and does not feel the added cost will be of benefit to his business entity.

Chuck Moser, DRC member, states that the small claims are not a large part of the DRC.

Commissioner Hawkins advocates for the DRC and feels that the service gives a sense of closure to the outcome of the process.

Lynn Yialelis speaks that the DRC benefit exists for more than just how many cases are heard. There is an outreach education factor through the service for resolving conflict and disputes.

Vicky Visculgia also speaks on the protection of the consumer for credit services which is regulated and governed by law.

Judge Nakata would like to see what the consumer is paying for and what the benefit they are getting from the service and that more information is needed.

Judy Hesburn from Olympic Credit also feels that they are a dispute resolution center and in ten years she has not seen a need for the use of this service. She feels it is unfair for the credit services to be the main source of funding when they would not benefit from the service.

Sandi Harrison feels this will be more work for the clerks to track and collect these fees.

Judge Harmon feels that it is an admirable cause and the work the DRC has done has been valuable and will be a benefit of the community. But the cost to the consumer should be reduced from the proposal with a total fee of \$25 and \$50 fees instead of the proposed fee. A pilot program with review would be the desirable form of implementation.

TJ Farrel notes that there are other persons that will benefit from this.
