## RESOLUTION 2022- /07

A resolution of the Chelan County Board of Commissioners declaring certain county owned real property parcels as surplus and unnecessary for county purposes and to authorize conveyance of the same.

Whereas, Chelan County owns various parcels of real property throughout the county; ownership of real property is necessary for county government to fulfill its duties and purposes, and

Whereas, Chelan County has become the owner of some parcels by operation of law such as tax title property and remnant parcels; not all such parcels are needed to fulfill county duties and purposes, and

Whereas, attached hereto and incorporated herein as Exhibit A is a list of county-owned parcels that are not necessary for the county to own in order to fulfill county duties and purposes, and

Whereas, this board conducted a duly advertised public hearing on October 31, 2022, regarding the surplus status of each parcel in attached Exhibit A, and

Whereas, this board has determined that it is in the best interests of the county and the taxing districts and the people thereof for the county to declare as surplus and unnecessary for the county to own each and all of the parcels listed in attached Exhibit A and to relieve the county of the burdens commensurate with ownership thereof, and

Whereas, pursuant to the provisions of state law including but not necessarily limited to Chapters 36.34 and 36.35 RCW, and Chelan County Code Section 1.70.572, the county shall convey each and all of the parcels listed in attached Exhibit A in a manner consistent with state law and county code, and

Whereas, various methods of conveyance are possible; some parcels may qualify for public auction, some for conveyance to another municipal entity, and some to abutting owners. Any conduct of a public auction shall be scheduled and supervised by the Treasurer. Further, the Treasurer shall also schedule and supervise any and all other manner of transfers of title to the parcels listed in attached Exhibit A, in a manner consistent with applicable law.

Now, therefore, it is hereby resolved that each and every parcel listed in attached Exhibit A is hereby declared as surplus and their conveyance either via sale at public auction or other transfer of title consistent with applicable law is hereby authorized.

It is hereby further resolved that the foregoing recitals are adopted and incorporated herein as findings, conclusions, and orders of this board.

It is hereby further resolved that this resolution is in the best interest of good governance.
