#### What is Tax Increment Financing?

- Designates a Tax Increment Area TIA
- A TIA and TIF are the same thing
- Identifies infrastructure improvements
- Collects "increment" property tax revenues
- Invests those revenues within TIA boundaries
- Designed to help revitalize **DISTRESSED** areas

# Malaga Draft TIA Boundary (3,326 acres) TIA Parcels 1 mi

#### Proposed Boundary

Includes Microsoft development, Helion fusion plant and the former Alcoa plant. Microsoft and Helion are currently under construction.

# Regional Port's Proposal

- Shows \$108 million taken from Chelan County
- Shows \$70.5 million taken from Wenatchee Valley Fire
- Shows \$17 million taken from NCW Libraries
- Total: Shows \$206 million taken from all taxing districts
- Bond against revenues for possible projects
- Redevelopment of Alcoa property

# Captured Incremental Tax Revenues from Taxing Districts: 25-Year Total

Taxing District	Captured Incremental Tax Revenue	% of District Revenue
County General	\$49,900,000	8.0%
Regional Library	\$17,000,000	8.0%
Port District	\$10,600,000	8.0%
County Road District	\$55,600,000	13.0%
Flood Control Zone	\$2,700,000	8.0%
Wenatchee Valley Fire District	\$70,500,000	17.6%
Total	\$206,300,000	11.3%

The total above is slightly lower than total tax allocation revenues received due to indirect impacts on levy rates.

# What are the Impacts?


- Taking the county revenues will impact Sheriff, Prosecutor, election administration, road preservation, veteran services and more.
- Regional Port cites large revenues to the county over time, based on speculative projects and sales tax revenues.
- •In reality, the county will eventually be taking money out of its general fund to pay for the TIF.

# Impacts to County Roads

- Road Fund does not receive sales tax dollars.
- Road Fund is mainly dependent on the road levy.
- Commissioners may have to look at ways to pay for projects, like a **Transportation Benefit District**.
- •Roads across the county will suffer if increased maintenance is required in Malaga.


#### Impacts to County Roads

## Impacts to You

- County may have to seek other ways to generate revenues.
- Residents across the county will be making up for the loss of funds.
- Your property taxes will not be as low as they would be without a TIF.
- •County services will be impacted affecting residents at all levels, from law enforcement to roads.



### What is the County Doing?

- 6-month moratorium on TIFs in unincorporated Chelan County.
- RCW 36.70A.390: Private development that is anticipated to occur within the increment area as a result of the proposed public improvements will be permitted consistent with the permitting jurisdiction's applicable zoning and development standards.
- •County is in the process of updating its Comprehensive Plan and Transportation Element and establishing an Urban Growth Area for unincorporated areas in Chelan County.
- •We need time to complete our plans to better determine how a TIF truly impacts our community.


