## I. CALL TO ORDER

Hearing Examiner Kottkamp called the Hearing to order at 1:00 pm. No objections were given to Mr. Kottkamp running today's hearing. Instruction was given to attendees on how the hearing is conducted and how to participate, testify, and appeal a decision.

#### II. PUBLIC HEARINGS

**AA 21-275:** An Administrative Appeal application was submitted, appealing the Notice and Order to Abate issued on June 8, 2021 for development including grading, filling, and the installation of concrete pads and electrical boxes in a flood hazard zone without the appropriate permits. Project Location: 13865, 13867, 13869, 13871, and 13875 Brae Burn Road, Lake Wenatchee, WA 98826; Parcel Numbers: 27-17-27-485-337, 27-17-27-485-338, 27-17-27-485-339, 27-17-27-485-341, and 27-17-27-485-342. **Planner – Molly McGuire** 

Mr. Kottkamp discussed the application details, and entered the staff-report, attachments to the staff-report, application materials, and entire planning staff files into the record. Planner Molly McGuire explained the application, after giving a brief correction made on Page 1 of the staff-report. Staff recommends that the Notice and Order be Affirmed.
