I. CALL TO ORDER

II. PUBLIC HEARINGS

AA 22-128: A request for an Administrative Appeal was submitted to appeal the denial of a short-term rental permit as an existing non-conforming short-term rental. Project Location: 23336 Lake Wenatchee Hwy, Leavenworth, WA 98826; identified by Assessor's Parcel No.: 27-16-14-210-100. **Short-term Rental Manager – Kirsten Ryles**

This application was continued until the May 4, 2022, Hearing Examiner meeting, at 9:00 am.

AA 22-116: A request for an Administrative Appeal was submitted to appeal the denial of a short-term rental permit as an existing non-conforming short-term rental. Project Location:

9864 E Leavenworth Rd, Leavenworth, WA 98826; and identified by Assessor's Parcel No.: 24-17-12-543-430. **Short-term Rental Manager – Kirsten Ryles**

Mr. Kottkamp discussed the application details, and entered the staff-report, attachments to the staff-report, application materials, site plans, and entire planning staff files into the record. Short-term Rental Manager Kirsten Ryles presented the application. Staff recommends that the denial be upheld.

CUP 21-291: An application for a Conditional Use Permit has been submitted by Mark Reimer (owner) for the development of three dispersed campsites. Each campsite will have a 12-ft x 12-ft canvas tent placed on a 12-ft x 16-ft platform. Parking for all three campsites will be at a gravel parking lot off of Chelan Ranch Road, potable water will be toted in by the user, and a portable toilet will be provided at each location. The subject property is zoned Rural Residential/Resource 10 (RR10). Project Location: 36 Mountain Ridge Lane, Chelan, WA 98816; and identified by Assessor's Parcel No.: 28-22-34-130-025. **Planner – Alex White**
