CUP 23-358 Balloun- An application was submitted for the permitting of an existing residence as a 5-bedroom/10-person Tier 2 Short Term Rental within the Commercial Agricultural Lands (AC) zoning district pursuant to the District Use Chart in Section 11.04.020 of the Chelan County Code. Access to the residence being used as the short-term rental would continue to be from Nora Lane, a private access easement off of Boyd Rd., domestic water for the residence would continue to be from a shared private well located on an adjacent property, and sanitation would continue to be from an existing septic system located on the subject property. 81 Nora Lane, Chelan, WA 98816; APN 28-22-33-140-110
