## AA 25-128 Shank - CONTINUED TO SEPTEMBER 17<sup>TH,</sup> 2025 AT 1:00 PM

**CUP 25-078 Dell RV Park -** The applicant is requesting Conditional Use Permit approval for a Minor Recreational Vehicle Campground containing a mix of RV sites and cabins and other accessory uses. The applicant is also requesting a waiver from required landscaping provisions found in CCC 11.93.330(10)(A). Access to the proposed campground will be provided via a private easement drive on parcels 26-21-01-420-050 and 26-21-01-130-075. 19800 US HWY 97A, Chelan WA and is identified by Assessor's Parcel number: 26-21-01-430-150.

**CUP 25-081 Malaga Water District** - An application for a Conditional Use Permit amendment has been requested for a High Impact Utility. This application proposes to amend CUP 13-059 to allow up to five additional wells and two well houses. Each well house would include an approximately 1,200 gallon per minute well pump, centralized data logger for the district's telemetry system and piping to connect into the District's existing system. Each well house would consist of an approximately 24 ft x 32 ft building. Access to the property is from W. Malaga Rd and the subject property is zoned Rural Village (RV). 3780 W. Malaga Road, Malaga, WA 98828 and is identified by Assessor's Parcel number: 22-21-28-420-050.
