A. Requested Action

Repeal of Resolution No. 2019-085 for amendments to Chelan County Code (CCC) attached as Exhibit A. Requested actions include:

To make a recommendation to the Board of County Commissioners in regards to repealing Resolution 2019-85, an amendment to Chelan County Code Section 12.22.020 Plat alteration to clarify that a revised survey is required for modification of any cadastral elements and any modification to plat notes, names, or other type of text only changes can be modified on the original subdivision with county approval to be filed with the county auditor. The repeal is necessary because the amended code does not comply with state law under RCW 58.17.

The Planning Commission is being asked to review, consider, and make a recommendation to the Board of Chelan County Commissioners to approve, approve in part or deny the repeal of Resolution 2019-85 Land Divisions Code amendments relating to Plat Alterations.

The proposed text amendment is exempt from SEPA review pursuant to WAC 197-11-800(19)(a).

C. Code Review Criteria

The approval, modification or denial of a development regulation amendment application shall be evaluated on, but not limited to, the following criteria:

CCC 14.13.040 (1) The amendment is necessary to resolve a public land use issue or problem.

CCC 14.13.040 (2) The amendment is consistent with goals of the Growth Management Act, Chapter 36.70A RCW.

CCC 14.13.040 (3) The amendment complies with or supports comprehensive plan goals and policies and/or county-wide planning policies.

CCC 14.13.040 (4) The proposed amendment does not adversely affect lands designated as resource lands of long-term commercial significance or critical areas in ways that cannot be mitigated.

CCC 14.13.040 (5) The amendment is based on sound land use planning practices and would further the general public health, safety and welfare.

Staff Analysis:

The repeal of Resolution 2019-85 would return the text within CCC 12.22 Plat Vacations and Alterations to read as it did prior to the adoption of Resolution 2019-85. The original text was reviewed on the criteria provided above and found consistent. The reason the repeal of Resolution 2019-85 is that the text was not given legal review after modifications from the original draft. Upon implementing the text amendment, it was discovered that the text amendment was not consistent with the RCW 58.17. This is outlined in the draft Resolution for repeal that is attached as Attachment A.

D. Suggested Findings of Fact:

- 1. Reviewing agencies and the general public were given an opportunity to comment on the proposed amendments.
- 2. The amendments are consistent with Chelan County Code Title 14 Development Permit Procedures and Administration.
- 3. The proposed text amendment is exempt from SEPA review pursuant to WAC 197-11-800(19)(a).
- 4. The Land Divisions Ordinance Chapter 12.22, Plat Vacations and Plat Alterations, have been contemplated.
- 5. The Chelan County has adopted the Chelan County Comprehensive Plan pursuant to the Growth Management Act (GMA), RCW Chapter 36.70A.

- 6. The Chelan County Planning Commission is responsible for long range planning matters and providing implementation recommendations to assure compliance with the Growth Management Act for Chelan County in coordination with Chelan County and within the incorporated boundaries of the City of Wenatchee. These measures include updates and amendments to the comprehensive plan; development regulations, environmental regulations, and any other rules, actions or regulations deemed necessary to implement the Growth Management Act.
- 7. RCW Chapters 36.70 and 36.70A authorize the adoption of development regulations.
- 8. A public hearing date with the Planning Commission was published in the Wenatchee World on January 9, 2020 for the proposed repeal.
- 9. On January 7, 2020, the Chelan County provided formal notice to the Washington State Department of Commerce of the intent to adopt amendments to the Chelan County Code and initiation of the 60 day review and comment periods. The comment period ends March 7, 2020.
- 10. On January 22, 2020, the Chelan County Planning Commission conducted an advertised public hearing. The Planning Commission entered into the record the files on this amendment, accepted public testimony, and deliberated the merits of the proposal.
- 11. The Chelan County Planning Commission has reviewed the entire record and public testimony as it relates to the proposed amendments to the Chelan County Code.

E. Suggested Conclusions of Law:

- 1. The procedural and substantive requirements of the State Environmental Policy Act have been complied with.
- 2. The procedural requirements of RCW 36.70A have been complied with.
- 3. The proposed amendments are consistent with the Chelan County Countywide Planning Policies and the Chelan County Comprehensive Plan.
- 4. The proposed amendments are consistent with the requirements of Revised Code of Washington, and the Washington Administrative Code.
- 5. The proposed amendments have been reviewed and processed in accordance with the requirements of Title 12 Land Divisions and Title 14 Development Permit Procedures and Administration of the Chelan County Code.

A resolution repealing Resolution 2019-85 amending CCC 12.22.020 regarding the procedure governing plat alteration.

WHEREAS, pursuant to RCW 36.32.120 the Chelan County Board of County Commissioners may not make or enforce police and sanitary regulations that are in conflict with state law;

WHEREAS, alteration of a subdivision is governed by RCW 58.17.215-.218;

WHEREAS, RCW 58.17.215 provides that an application seeking alteration of a subdivision shall be submitted to the county legislative authority, that notice of the application shall be provided to all owners of property within the subdivision, and that such notice "shall either establish a date for a public hearing or provide that a hearing may be requested by a person receiving notice within fourteen days of receipt of the notice";

WHEREAS, on July 30, 2019, the Chelan County Board of County Commissioners adopted Chelan County Resolution No. 2019-85 which amended CCC § 12.22.020, entitled "Plat Alteration", to provide that "(6) After approval of the alteration, the applicant shall submit to the county a revised drawing of the approved alteration of the subdivision. The revised plat shall be prepared by a Washington State licensed land surveyor, except as provided in subsection (7) of this section. (7) Amendments not involving the location of lot lines, number of lots, or easements established by the subdivision may be approved by the administrator. An affidavit must be recorded with the Chelan County auditor referencing the subdivision or short subdivision being altered."

WHEREAS, Chelan County Resolution 2019-85 conflicts with the requirements of RCW 58.17.215 which state that after the approval of the alteration, the legislative body shall order the applicant to produce a revised drawing, (and not merely an affidavit), of the approved alteration of the final plat or short plat, which after signature of the legislative authority, shall be filed with the county auditor to become the lawful plat of the property;

WHEREAS, according to CCC §§ 14.12.020-.030 public hearings do not occur in an administrative review process; and further, according to CCC § 1.61.080, the hearing examiner has authority to hear and decide applications for plat alterations not the administrator;

WHEREAS, Chelan County Resolution 2019-85 does not provide within Chapter 12.22 of the code that a public hearing or notice for a public hearing consistent with RCW 58.17.215 is required;

WHEREAS, Chelan County Resolution 2019-85 thus conflicts with RCW 58.17.215's public hearing requirements and with CCC § 1.61.080 which vests the hearing examiner with authority to hear and decide applications for plat alterations;

WHEREAS, adoption of Chelan County Resolution 2019-85 by the Chelan County Board of County Commissioners was in error;

RESOLUTION NO. 2019-123

A resolution enacting a moratorium on implementation of Resolution 2019-85.

WHEREAS, pursuant to RCW 36.32.120 the Chelan County Board of County Commissioners may not make or enforce police and sanitary regulations that are in conflict with state law;

WHEREAS, alteration of a subdivision is governed by RCW 58.17.215-.218;

WHEREAS, RCW 58.17.215 provides that an application seeking alteration of a subdivision shall be submitted to the county legislative authority, that notice of the application shall be provided to all owners of property within the subdivision, and that such notice "shall either establish a date for a public hearing or provide that a hearing may be requested by a person receiving notice within fourteen days of receipt of the notice";

WHEREAS, on July 30, 2019, the Chelan County Board of County Commissioners adopted Chelan County Resolution No. 2019-85 which amended CCC § 12.22.020, entitled "Plat alteration", to provide that "(6) After approval of the alteration, the applicant shall submit to the county a revised drawing of the approved alteration of the subdivision. The revised plat shall be prepared by a Washington State licensed land surveyor, except as provided in subsection (7) of this section. (7) Amendments not involving the location of lot lines, number of lots, or easements established by the subdivision may be approved by the administrator. An affidavit must be recorded with the Chelan County auditor referencing the subdivision or short subdivision being altered."

WHEREAS, Chelan County Resolution 2019-85 conflicts with the requirements of RCW 58.17.215 which state that after the approval of the alteration, the legislative body shall order the applicant to produce a revised drawing, (and not merely an affidavit), of the approved alteration of the final plat or short plat, which after signature of the legislative authority, shall be filed with the county auditor to become the lawful plat of the property;

WHEREAS, according to CCC §§ 14.12.020-.030 public hearings do not occur in an administrative review process;

WHEREAS, according to CCC § 1.61.080, the hearing examiner has authority to hear and decide applications for plat alterations;

WHEREAS, Chelan County Resolution 2019-85 does not provide within Chapter 12.22 of the code that a public hearing consistent with RCW 58.17.215 is required;

WHEREAS, Chelan County Resolution 2019-85 also conflicts with RCW 58.17.215's public hearing requirements;

WHEREAS, Chelan County Resolution 2019-85 also conflicts with CCC § 1.61.080 which vests the hearing examiner with authority to hear and decide applications for plat alterations;

WHEREAS, adoption of Chelan County Resolution 2019-85 by the Chelan County Board of County Commissioners was in error;

WHEREAS, Chelan County code requires the proposed repeal of Resolution 2019-85 be first reviewed by the Chelan County Planning Commission which takes several weeks to accomplish;

WHEREAS, this matter will be submitted to the Planning Commission for review and recommendation consistent with RCW 36.70.040;

WHEREAS, Chelan County is authorized pursuant to RCW 36.70A.390 to enact a moratorium effective immediately upon adoption on the implementation of a code provision which conflicts with state statute;

WHEREAS, a moratorium effective immediately is necessary to afford predictable and consistent implementation of land use law and is in the best interest of public health, safety, welfare, and provides good governance.

NOW THEREFORE, BE IT HEREBY RESOLVED by the Chelan County Board of County Commissioners that a moratorium on the implementation of Chelan County Resolution No. 2019-85 is hereby enacted effective immediately and a public hearing on this matter will occur no later than sixty days from date of this resolution on January 7, 2019.

Be it further resolved, this moratorium will be for a period not to exceed six months unless extended for good cause by resolution at a later date;

Be it further resolved, while this moratorium is in effect, no application for a plat alteration will be subject to the provisions of Resolution 2019-85;

Be it further resolved, the foregoing recitals are hereby adopted as findings of fact and conclusions of law;
