Continuation of Public Hearing Docket # 9 Capital Improvement Plan (CIP)

Doug England states there were questions with numbers not adding up when it came to expenditures.

Commissioner Viki Malloy states that a number of projects were not approved by the County Commissioners, but put on the CIP.

Cathy Mulhall states to be listed on the CIP it does not require pre-approval by the Board of County Commissioners.

Commissioner Cherie Warren states Ohme Garden Irrigation pump system numbers did not add up. As well as the Pavilion Air Conditioning. States it does not reconcile between the Worksheet and the CIP funds.

Cathy Mulhall states that request sheets were modified so there could be discrepancies, but the Excel sheet is correct.

Commissioner Cherie warren requests REIT funds, Cathy Mulhall will send them over.
