Hello planning commission

We have owned our home on Cedar street for over 20 years. Last year we bought a condo in Alpine Village as a second home for extended family and friends to stay in when they occasionally come to town and be able to use it as a short term rental when empty.

We pay appx \$6,000 per year in property taxes on our Cedar street house, and appx. \$3,100 on the condo.

We strongly believe that the proposed restrictions on short term rentals are grossly unfair and ultimately bad for both Leavenworth as well as the taxpaying individuals like us that have invested significant assets in them.

If you consider the hotel/motel occupancy numbers since STRs began, they have increased rather than decreased. The proof is the new Hampton Inn next to Safeway. If the demand for rooms wasn't sufficient to justify their investment, they wouldn't have built. So STR's are an incremental business, not a replacement for hotel rooms....which if you follow to the logical conclusion, STR's bring more visitors to town that don't want to stay in a hotel/motel, for a variety of reasons. Increased occupancy...both STR and hotel/motel... is good for lots of businesses in town: restaurants, shops, tourist activities, etc. It is literally the lifeblood of our economy.

I'm writing on behalf of my small business friends and I want to urge you to think carefully about your developments for Short Term Rentals. As you know, our community and our nation thrives on small businesses just like these. Rentals play a key part in our highly valuable tourism industry. We all understand the need for regulation for safety and well being of our communities. Too often the error in any legislation is to be too limited and the powerless are exploited or it's restrictive and the powerless are exploited. I want to share with you a few of the concerns I have been receiving on this issue.

Limiting group sizes to 10. We should be careful to avoid a discrimination here against small businesses vs. larger lodging establishments. I hope we are not considering imposing the same restrictions on hotels and resorts. Obviously we should think critically about the various facility sizes, capacities, and sanitizing practices. We should also consider the traditional clientele of short term rentals are usually large families and the reputations of current STRs. I'm sure you are aware of the many factors in the industry. Making any adjustment in such a diverse sector will be incredibly difficult given the huge variations in the variables. A decision to make a broad decision like limiting group sizes to 10 would be a huge error. It would be like limiting all hotels to 50. We have rentals built specifically for much larger groups and others that are simply homes being rented. I think the impossibility of a perfect size to limit here is obvious.

One more item to consider is current code enforcement. The lack of enforcement on code violations like noise, garbage and parking have created problems for creditable business owners and the community at large. The community needs current code enforcement to remedy these issues. Creating new codes when the current codes haven't been enforced is most illogical and would likely not fix the problems. Why would we anticipate any new code would fix any issue when we know current codes are not being enforced and therefor not fixing the issues they were created for.

RE: Comments on Proposed Short-Term Rental Regulations

To whom it may concern:

Please accept the following comments on Chelan County's proposed regulations affecting Short-Term Rentals (STRs) as part of the record for the June 17, 2020 hearing for the proposed regulations. These comments are specific to the draft version of the regulations prepared by BERK Consulting dated May 29, 2020 and published on Chelan County's website.

I would like to first state my support for the proposed regulations generally, as the proliferation of STRs in my community of Manson has adversely affected the quality of life here in many ways including noise issues, availability and affordability of housing and contractors, overcrowding on weekends, excessive traffic, and loss of small-town feel. I've heard many stories of local residents whose quality of life has been severely diminished due to STRs in their neighborhoods, in some cases causing valued community members to sell their homes to move elsewhere.

My specific comments on the draft text of the proposed STR regulations are as follows.

Comment 1 – Pertains to 11.88.280(2)(A)(i), starting at line 148

My preference is for Option 2 with the following changes: a) add underline word "...present at the dwelling during the <u>entire</u> rental period...." and b) replace underlined number "....no more than <u>14</u> total days...".

Justification for Comment 1

Significant owner oversight is sufficiently achieved if the owner is present during the entire period when the home is being rented (even if not principle residence). Thirty (30) days of rental is a lot and should push the STR into Tier 2 status (a home could be rented every weekend over the entire summer and still fall short of 30 days). The suggested 14 days in consistent with Internal Revenue Service rules specifying that rental of a home for more than 14 days is significant and constitutes turning the home rental into a business.

Comment 2 – Pertains to 11.88.280(2)(A)(ii), starting at line 154

Suggest replacing entire requirement with "A short-term rental that is not Tier 1 or Tier 3."

Justification for Comment 2

Simplifies and removes any ambiguity.

Comment 3 – Pertains to 11.88.280(2)(B)(i), starting at line 162

My preference is for Option 1.

Justification for Comment 3

There is no reason not to have Tier 1 STRs subject to the 1% cap, and this keeps the requirement much simpler. The purpose of the 1% cap is to slow growth of STRs in Chelan County and that should include all tiers of STRs.

Comment 4 – Pertains to 11.88.280(2)(E)(ii)(b), starting at line 261

Remove text in strikeout "....combined percentage of Tier 2 and Tier 3 short-term rentals"

Justification for Comment 4

There is no reason not to include Tier 1 STRs in this cap <u>unless</u> Chelan County accepts the changes requested in Comment 1 above. Without the changes requested in Comment 1, Tier 1 STRs will still have a significant negative impact on neighboring homes.

Comment 5 – Pertains to 11.88.280(2)(E)(iii)(b), starting at line 283

Replace with the following: "(b) That a location was used for short-term rental purposes during January 1, 2019 to May 29, 2020. The Director may permit homes with building permits approved by May 29, 2020 to be short-term rentals if constructed within twelve months of approval and this was the intended purpose of the home when the building permit was approved."

Justification for Comment 5

This is an extremely important issue. The effective date for this requirement defining "existing" STRs should be the date of the proposed regulations, not the final date of approval. This is done to prevent a "gold rush" of STR plans between the date of the proposed regulations and when they are finalized. All potential future STR owners should now be aware that Chelan County is preparing to further regulate STRs, and these regulations will look something like what has been proposed. It is up to the potential future homeowners to assume the risk that the final regulations may be as stringent, or even more stringent, than what has been proposed.

This is a common approach for new regulations that tighten regulatory requirements. For example, for the dozens of rules establishing emission standards promulgated under 40 CFR Part 63, in most (if not all) cases, "existing" affected sources (which have less stringent emission standards) are defined as those existing prior to the date that the rule was <u>proposed</u>; all sources established after the date of the proposed rule are considered to be "new" sources (which have more stringent emission standards).

Comment 6 – Pertains to 11.88.280(2)(E)(iii)(f), starting at line 297

Replace with underlined text as follows: "...per 11.23.040 <u>during all rental periods between January 1, 2019 and XXX [effective date]."</u>

Justification for Comment 6

As currently worded, the regulation would allow STRs that are currently operating illegally to establish "existing" STR status by simply obtaining a permit by the effective date of the new regulations. This is not fair or just for those STRs that are currently operating legally within the Manson UGA. If an STR is currently operating illegally, it should not be allowed as an "existing" STR.

Comment 7 – Pertains to 11.88.280(2)(E)(iii) starting at line 300

Add requirement (g) as follows:

(g) Once an Existing Short-Term Rental is sold to a new owner, it no longer qualifies as an Existing Short-Term Rental.

Justification for Comment 7

As explained in the notes associated with the proposed code 11.88.280 (see lines 240-241), several areas, including Leavenworth and Manson, are well above (more than twice) the target density of 5%. Without the requested language above, the attrition rate for STRs to get down to the desired density of 5% in these areas will likely take a decade or more, causing these communities to unduly suffer for a prolonged period of time. Since this does not infringe on the rights of the current owners of STRs, there is no reason not to add this language.

Comment 8 – Pertains to 11.88.280(3)(C)(i) starting at line 331

It is unclear what "...in addition to the residential parking requirements..." means in this requirement. I'm assuming that this requirement essentially says that the STR must provide one off-street parking spot for each bedroom being made available. However, I suggest that the requirement be more explicit about what "...in addition to the residential parking requirements..." means, presumably referencing some other portion of the Chelan County Code.

Justification for Comment 8

It is important to have clarity for all regulatory requirements.

Comment 9 – Pertains to 11.88.280(3)(E) starting at line 343

Add the following underlined text: "...in compliance with Chapter 7.35 Noise Control <u>and WAC 173-60</u> <u>Maximum Environmental Noise Levels."</u>

Justification for Comment 9

Here in Manson, we have recent examples of the practical unenforceability of the county noise ordinance in Chapter 7.35 referenced in this section of the proposed regulation. Specifically, the Chelan County Sheriff's department has shown an unwillingness to provide enforcement on behalf of Manson residents. As such, simply including a reference to this unenforceable noise requirement is inadequate.

Although WAC 173-60 would apply regardless of it being specifically mentioned, adding it here reinforces Chelan County's support for utilizing the quantitative noise levels contained therein. To supplement this, I hope that Chelan County will continue to work with the Chelan County Sheriff's department to effectively enforce WAC 173-60 to protect the public from excessive noise (perhaps by providing one or more calibrated noise measuring devices for Sheriff's deputies to use).

Comment 10 – Pertains to 11.88.280(4)(I) starting at line 484

Request that proposed Option 1 be used.

Justification for Comment 10

Going through the permit application process is the only way to confirm that the new owner fully understands, and is willing to comply with, the STR requirements in 11.88.280.

Summary

Thank you for considering the requested changes to the proposed STR regulations provided by Chelan County. I do believe that these proposed regulations, along with the changes I have requested, will go a long way toward ameliorating the significant negative impact that STRs have had on the Manson community specifically and Chelan County more generally.
