I acknowledge and understand that short-term rentals are any unit being rented for less than thirty consecutive days and shall be permitted as identified in Chelan County Code (CCC), Section 11.88.290. I am limited to renting only one (1) designated dwelling Owner Applicant unit per parcel. All short-term rental permits expire December 31st of the year issued. I understand that my permit must be renewed annually or I lose my permit status and must start the application process over as a new applicant. I acknowledge and understand that overnight occupancy of the STR cannot exceed the amount on issued permit, that daytime occupancy cannot exceed tier level allowance unless a Conditional Use Permit (CUP) has been issued to the property and is on file Owner Applicant with the STR Department. I acknowledge and understand that all short-term rentals shall be immediately and continuously compliant with sewer/septic permitting for allowed number of bedrooms/occupancies, insurance requirements, and Fire & Life Safety inspection(s). I shall Owner Applicant comply with CCC section 11.88.290 and all applicable building, sewage, and fire codes (as amended). I acknowledge and understand that all short-term rentals shall provide year-round solid waste receptacles and pick up service. Trash cans on the right-of-way shall be removed within twelve (12) hours of pickup and that noise emanating from any use shall be Applicant in conformance with CCC, Section 7.35. I acknowledge and understand that all short-term rentals shall provide at least one (1) off-street parking space per bedroom, outside of any recorded access easements, plus one (1) for any on-site owner, caretaker, or qualified person. Additional off-street parking Owner Applicant spots must be provided if STR also has a CUP at 1 spot per 4 chairs or 4 feet of bench space. I shall, as designated in CCC 11.88.290(3)(G), display and maintain the address of the residence so that it is clearly visible from the street or access road in compliance with Section 10.20.520 requirements. STRs must also display and maintain an additional sign Owner Applicant outside identifying the property as a short term rental and displaying the Chelan County short term rental permit number and contact phone number of their qualified person required by the County. The sign must not exceed eight (8) square feet in area, if illuminated must be indirectly illuminated, letters/numbers must be a minimum of four (4) inches in height, and sign must be all-weather and permanently posted. I certify that I am the property owner, or authorized agent of the property owner, and I have familiarized myself the short term rental code of Chelan County with respect to making this application and that I possess full legal authority and rights necessary to exercise Owner Applicant control over the subject property. I further certify that this application has been made with the consent of the lawful property owner(s) If applicant different than owner. Lacknowledge and agree that my short-term rental permit expires each year on December 31 and that I am required to apply for renewal between September 1 - October 31 each year I intend to keep the STR permit. Owner Applicant I acknowledge and agree that photographic proof of required signage is required every year as part of the renewal process. Applicant If permanent contact information changes during the permit period, the information must change on the sign. If I was granted a sign waiver, I must provide proof of annual mailings as prescribed with a copy of the letter sent. I acknowledge and understand that any violation of Chelan County building or zoning regulations, as well as any violation of any provisions of a short-term rental permit is subject to enforcement pursuant to CCC, Title 16. Enforcement actions may be brought Owner Applicant against the owner of the vacation rental home for the conduct constituting the violation. I acknowledge and understand that if the property listed on this application is part of a Home Owners Association (HOA) or neighborhood covenant prohibiting the operation of an STR that those are civil matters the County does not participate. If the STR is Applicant not allowed to operate due to an HOA or covenant agreement, application fees are non-refundable. I acknowledge and agree that the assigned STR permit number must be included in all advertisements and I will ensure its Owner Applicant prominent display on any online platforms and other forums for rental (AirBnB, VRBO, Craigslist, poster, etc.) and on marketing materials such as brochures and websites. Lacknowledge and understand that: when/if an STR permit is issued, a signed copy of the permit must be returned promptly.
