

If you registered to vote online, or when you obtained your driver's license, the signature on your driver's license is the signature in your voter registration record.

If you are unsure about the signature in your voter registration record, we encourage you to call the Elections Office at (509) 667-6808. We can provide a verbal description of the signature you used when you registered to vote.

You can update your signature by submitting a completed voter registration form. You can do that online at VoteWA. gov using your valid Washington State driver's license or ID.

Your vote makes a difference. I encourage you to join me in exercising one of the most precious rights we have as Americans - the right to vote. I hope you will join in by casting your ballot in the General Election on November 2. Every vote counts!

Voting in Washington State

Registering to vote

Registering only takes a few minutes, and you may do it by mail or online at VoteWA.gov.

A Washington driver's license or ID is required to register online.



The deadline to receive new voter registrations and voter updates to existing registrations online, by phone or by mail is 5 pm Monday, October 25, 2021.

You may still register and update exisiting voter registrations after October 25th, but you must do so in person by 8 pm Tuesday, November 2.

Who is eligible to vote

The requirements for registering to vote are simple. You must be a United States citizen, 18 years or older on November 2, 2021 and live in Chelan County 30 days prior to the election.

How to vote

Chelan County voters will receive their ballots by mail. If you are a registered voter in Chelan County, we will mail you a ballot for every election in which you are entitled to participate.

Page 4 in this pamphlet explains how to vote using the Chelan County voting process. Please read the instructions in this pamphlet. We want your vote to count.

Accessible voting

Chelan County Elections is committed to ensuring that all voters have the opportunity to vote a private and secure ballot.

Accessible Voting Units (AVUs) are available starting 18 days before an Election, until 8pm on Election Day.

An AVU is a voting assistance unit that enables voters with visual impairments, cognitive/learning disablilites, illteracy, or limited mobility to vote independently and privately.

An AVU presents your ballot on a monitor, you select choices by touching a screen, using a select wheel, or by using a tool. You can use headphones to listen to the text and prompts on your ballot. AVUs can also be fitted with sip-and-puff tools. AVUs are wheelchair accessible and screened from others to maintain privacy.


How to vote

Here are a few important reminders to make sure your ballot is counted.

Mark your ballot by completely filling in the box to the left of your choice with a black or blue ink pen. If you want to vote for a candidate not appearing on the ballot, mark the box to the left of the dotted line provided to indicate your choice. Be sure to mark only one choice for each race on the ballot.


Example: Candidate 2 has been chosen.

One candidate has been marked and the box is filled in completely.



Check your ballot to be sure you have voted for the candidates you intended. Make sure you mark only one response box in each race. If you mark more than one, your vote in that race will not be counted. Your other votes will be counted if they are done correctly. Leaving an office blank will not invalidate your ballot.

If you make a mistake marking your ballot, draw a line through the incorrectly marked choice as shown. You then have the option of marking another choice.



You must sign and date your return envelope in order for your ballot to be counted!

- Sign in the signature box that has your YOUR name printed on the envelope.
- If you registered to vote online, or when you obtained your driver's license, the signature on your driver's license is the signature in your voter registration record.
- If you are unsure about the signature in your voter registration record, we encourage you to call the Elections Office at 509-667-6808. We can provide a description of the signature you used when you registered to vote.
- Do NOT sign someone else's name, even if you have power of attorney.
- Voting over the phone by having someone else fill out and sign your ballot is against the law. Voters can call us at 509-667-6808 to learn about the options for voting while they are out of town.
- Drop boxes are available if you don't want your signature to go through the mail. See page 3 for a list of ballot deposit locations.

Ballots dropped at the Post Office or blue postal bin on Election day, are not always date stamped the same day.

We strongly reccomend returning your ballot as early as possible. Mailed ballots must be postmarked by November 2, 2021.
