

PROPOSITION NO.1

CONCERNS THE PORTS OF CHELAN AND DOUGLAS COUNTIES UNIFYING TAX LEVY RATES ACROSS DISTRICTS.

This proposition, as enacted by Resolutions 2023-1 and 2023-2, would unify the tax levy rate encompassing both districts collected in 2024 and in subsequent, consecutive years. The Port of Chelan County levy rate for 2023 is 0.175 cents/\$1,000 of assessed value. The Port of Douglas County levy rate for 2023 is 0.137 cents/\$1,000 of assessed value. Using 2023 levy rates, a unified tax levy would be approximately 0.164 cents/\$1,000 of assessed value for both districts. Should this proposition be: APPROVED
