## Voting in Washington State

## Registering to vote

Registering only takes a few minutes, and you may do it by

mail or online at www.VoteWA.gov.

A Washington driver's license or ID is required to register online.



The deadline to receive new voter registrations and voter updates to existing registrations online, by phone or by mail is 5 pm Monday, July 25, 2022.

You may still register and update existing voter registrations after July 25th, but you must do so in person by 8 pm Tuesday, August 2.

## How to vote

Chelan County voters will receive their ballots by mail. If you are a registered voter in Chelan County, we will mail you a ballot for every election in which you are entitled to participate.

Page 3 in this pamphlet explains how to vote using the Chelan County voting process. Please read the instructions in this pamphlet. We want your vote to count.

## Accessible voting

Chelan County Elections is committed to ensuring that all voters have the opportunity to vote a private and secure ballot.

Accessible Voting Units (AVU's) are available starting 18 days before an Election, until 8pm on Election Day.

An AVU is a voting assistance unit that enables voters with visual impairments, cognitive/learning disabilities, illiteracy, or limited mobility to vote independently and privately.

An AVU presents your ballot on a monitor, you select choices by touching a screen, using a select wheel, or by using a tool. You can use headphones to listen to the text and prompts on your ballot. AVU's can also be fitted with sip-and-puff tools. AVU's are wheelchair accessible and screened from others to maintain privacy.

## How to vote

## Here are a few important reminders to make sure your ballot is counted.

Mark your ballot by completely filling in the box to the left of your choice with a black or blue ink pen. If you want to vote for a candidate not appearing on the ballot, mark the box to the left of the dotted line provided to indicate your choice. Be sure to mark only one choice for each race on the ballot.

Example: Candidate 2 has been chosen.

One candidate has been marked and the box is filled in completely.



Check your ballot to be sure you have voted for the candidates you intended. Make sure you mark only one response box in each race. If you mark more than one, your vote in that race will not be counted. Your other votes will be counted if they are done correctly. Leaving an office blank will not invalidate your ballot.

If you make a mistake marking your ballot, draw a line through the incorrectly marked choice as shown. You then have the option of marking another choice.



To vote for a candidate not listed for that race, fill in the box to the left of the dashed line and print the name of the candidate. write-in Gen

# You must sign your return envelope in order for your ballot to be counted!

- Sign in the signature box that has your YOUR name printed on the envelope.
- If you registered to vote online, or when you obtained your driver's license, the signature on your driver's license is the signature in your voter registration record.
- If you are unsure about the signature in your voter registration record, we encourage you to call the Elections Office at 509-667-6808. We can provide a description of the signature you used when you registered to vote.
- Do NOT sign someone else's name, even if you have power of attorney.
- Voting over the phone by having someone else fill out and sign your ballot is against the law. Voters can call us at 509-667-6808 to learn about the options for voting while they are out of town.
- Drop boxes are available if you don't want your signature to go through the mail. See "Returning your ballot" in the next column for a list of ballot drop box locations.

## Mailing your ballot

If you are mailing your ballot, no stamp is required.

Ballots dropped at the Post Office or blue postal bin on Election day, are not always date stamped the same day.

We strongly recommend returning your ballot as early as possible. Mailed ballots must be postmarked by August 2, 2022.

## Washington State's New Voting Rights

## 17-year-old voters

New Washington Legislation passed in March of 2020 allows 17-year-olds who will be 18 by the November General Election to vote in the August Primary starting this year.



Sixteen and seventeen year-olds can pre-register and will automatically be registered when they are eligible to vote.

Go to www.VoteWA.gov and find out! Make sure your physical and mailing address(es) are current so you receive your ballot!

## Felony conviction and voting rights

New Washington Legislation went into effect January 1, 2022 regarding convicted felons and their right to vote.

## When is my right to vote restored?

- If you were convicted of a felony in a Washington State court, your right to vote is restored automatically once you are no longer serving a sentence of total confinement in prison.
- If you were convicted of a felony in another state or in federal court, your right to vote is restored automatically as long as you are no longer serving a sentence of total confinement in prison.
- You do not lose the right to vote for a misdemeanor conviction or a conviction in juvenile court.

## Registering to vote

Once your right to vote is restored, you must register to vote even if you were previously registered. You do not need a certificate of discharge to register to vote.

Chelan County Fire Protection District No. 1 and Douglas County Fire Protection District No. 2 have adopted a Joint Resolution approving the Wenatchee Valley Fire Department Plan ("Plan") concerning the creation of a Regional Fire Authority.

This proposition would approve the Plan and create the Wenatchee Valley Fire Department, effective September 30, 2022 to provide fire protection and emergency medical services funded by a property tax not to exceed \$1.50 per thousand of assessed value to be levied in 2022.

## **EXPLANATORY STATEMENT**

If voters approve Proposition 1, Chelan County Fire Protection District No. 1 and Douglas County Fire Protection District N. 2 will create the Wenatchee Valley Fire Department "WVFD" as a regional fire protection service authority operating under chapter 52.26 RCW effective September 30, 2022. The WVFD will operate under a single governing board consisting of three elected commissioners from Chelan FPD 1 and three elected commissioners from Douglas FPD 2.

The WVFD will be funded by a property tax not to exceed \$1.50 per thousand of assessed valuation to be levied in 2022 and collected in 2023. The WVFD property tax will replace the regular property tax levies of Chelan FPD 1 and Douglas FPD 2.

The Board of Commissioners of Chelan FPD 1 and Douglas FPD 2 have determined that the formation of the WVFD will allow the entities to consolidate resources and more efficiently and cost effectively deliver fire protection and emergency medical services to their citizens. ## **Argument For**

Our valleys Fire District's, Douglas County Fire District 2 and Chelan County Fire District 1, have decades of history of responding to each District's respective jurisdictions because neither District can provide sufficient resources alone. It takes a cooperation and collaboration.

Combining the two Fire Districts will allow for efficiencies in administration, facilities, response and specialty teams as well as efficiencies procuring apparatus and equipment.

However, this will not decrease the cost of operating the combined Fire District's now or in the future.

The increased cost is due to the need to hire additional firefighters. Our volunteer firefighters have declined by 70% in the past 10 years. Both Districts have strategically located fire stations that need to be staffed to adequately serve our community. Our District's are responding to over 5,200 incidents annually.

The increase in funding will allow a minimum of 2 firefighters at 7 fire stations.

Accepted - Signature review has been completed, the voter has been credited with voting, and the ballot is accepted.

Rejection/Challenged + Challenged Reason - Signature or ballot has been challenged. The Chelan County Elections Office will contact the voter.

Challenge Reasons:

## These challenge codes require action by the voter. The voter will be contacted by the Chelan County Elections Office.

**Unsigned** - The voter did not sign the declaration on the outside of the return envelope.

Signature Does Not Match - The signature on the return envelope does not match signature on file.

**ID Required -** The voter registration has failed the ID check and must provide ID before the ballot can be counted.

Power of Attorney - A Power of Attorney has signed the declaration on behalf of the voter. This is not allowed for voting purposes.

## The status for this code could change during processing.

**Hold** - Voter returned a previously issued ballot that has been superseded. If the ballot returned is the same ballot style as the current ballot, it will be counted. If different ballot style, the ballot must be held until 7 days after Election Day.

## Did you know that you can access your ballot online?

Lost or damaged ballots happen. There's an easy way to access and print your ballot right from home.

- Visit www.VoteWA.gov and enter required information to access your ballot.
- Make your selections on the computer or print out a blank ballot and fill it in by hand. If you choose to make your selections online, please double check those selections before and after printing your ballot.
- Return via mail or secure drop box, just like you normally would. No postage is required if using one of our ballot drop boxes.

Any registered voter can use the online ballot marking program to access and print their ballot.

Voters with disabilities can mark their choices on the ballot online. The online ballot marking program has been designed specifically to enable voters who are blind or have low vision to cast a private ballot.

- Update your address with the Elections Office whenever it changes. Address changes can be made online through www.VoteWA.gov, by email, mail or phone until 5 pm July 25. You may update your registration in-person until 8 pm on Election Day.
- If you are a snowbird or a college student, email or call to set up a seasonal or temporary mailing address.
- Return to Sender! If you receive a ballot for a person who does not live at your residence, write "Does not live here" on the unopened envelope and put it back in the mail.
- If you receive a ballot for a recently deceased voter, write "Deceased" on the unopened envelope and put it back in the mail. We will research and follow up.
