Applications for new voter registrations or updates by mail, over the phone, email or online must be received by the Chelan County Elections Office no later than April 15, 8 days before Election Day, April 23, 2024.

Beginning April 16, voters registering or updating their existing registration in time for the April 23 Special Election will need to appear in-person at any election's office no later than 8:00 p.m. on Election Day, April 23.
