Applications for new voter registrations or updates by mail, over the phone, email or online must be received by the Chelan County Elections Office no later than April 19th, 8 days before Election Day, April 27, 2021.

Beginning April 20th, voters registering or updating their existing registration in time for the April 27, 2021 Special Election will need to appear in-person at any election's office no later than 8:00 p.m. on Election Day April 27, 2021. Chelan County Elections Office is located at 350 Orondo Ave Level 3, Wenatchee.
