Applications for new voter registrations or updates by mail, over the phone, email or online must be received by the Chelan County Elections Office no later than July 25th, 8 days before Election Day, August 2, 2022.

Beginning July 26th, voters registering or updating their existing registration in time for the August 2, 2022 Primary Special Election will need to appear in-person at any election's office no later than 8:00 p.m. on Election Day August 2, 2022.
