Applications for new voter registrations or updates by mail, over the phone, email or online must be received by the Chelan County Elections Office no later than July 27th, 8 days before Election Day, August 4, 2020.

Beginning July 28th, voters registering or updating their existing registration in time for the August 4th Primary Special Election will need to appear in-person at their county of residence's elections office no later than 8:00p.m on Election Day August 4, 2020. Chelan County Elections Office is located at 350 Orondo Ave Level 3, Wenatchee.
