Applications for new voter registrations or updates by mail, over the phone, email or online must be received by the Chelan County Elections Office no later than January 31st, 8 days before Election Day, February 8, 2022.

Beginning February 1st, voters registering or updating their existing registration in time for the February 8, 2022 Special Election will need to appear in-person at any election's office no later than 8:00 p.m. on Election Day February 8, 2022.
