WHEREAS, Chelan County has previously entered into an agreement with Douglas County, the City of East Wenatchee, and City of Wenatchee that provides for the joint ownership and operation of RiverCom, a regional multi-jurisdictional E911 answering point and emergency public safety communications service, under the authority of RCW Chapter 39.34;

WHEREAS, RCW 82.14.420 authorizes the Board of County Commissioners to submit a proposition to Chelan County Voters for renewing the sales and use tax under RCW Chapter 82.08 and RCW 82.12 equal to one-tenth of one percent of the selling price or value of the article used;

WHEREAS, pursuant to RCW 82.14.420(3), the monies received from the collection of the tax shall be used solely for the purpose of providing funds for costs associated with financing, design, acquisition, construction, equipping, operating, maintaining, remodeling, repairing, reequipping, and improvement of emergency communication systems and facilities for RiverCom;

WHEREAS, the Douglas County Board of County Commissioners have adopted or will adopt a similar resolution submitting a proposition to Douglas County Voters for approval of the renewed sales and use tax;

WHEREAS, pursuant to RCE 82.14.420(5), Chelan County and the other members of the RiverCom Board, have reviewed and adopted an *Emergency Communications and Facilities Funding Agreement*;

WHEREAS, the renewal of the sales and use tax initiative, if approved by voters of both counties, shall continue indefinitely;

WHEREAS, Chelan County adopted Resolution 2019-55 on April 29, 2019, intending to order said sales and use tax measure; however, said resolution should be amended.

NOW THEREFORE, BE IT HEREBY RESOLVED, as follows:

- 1. The Board of Commissioners hereby authorizes the submission of a proposition to the voters of Chelan County as provided under RCW 82.12.420, for the continued funding via sales and use tax, under RCW Chapter 82.08 and RCW Chapter 82.12, equal to one-tenth of one percent of the selling price of the article sold or the value of the article used;
- 2. The sales and use tax shall not be imposed unless the proposition is placed before the voters of both Chelan County and Douglas County and the proposition is approved in both Chelan County and Douglas County;
- 3. If approved the sales and use tax shall have no sunset clause and be collected in perpetuity;
- 4. The Chelan County Auditor is directed to place the proposition to impose the continued sales and use tax on the ballot for the election to be held August 6, 2019;
- 5. The Prosecuting Attorney is directed to draft a ballot title and submit this to the Auditor.
- 6. This resolution supplements and, where inconsistent, supersedes Resolution 2019-55.
