

Nason Ridge Community Forest

- 4,000 acre tract
- Purchased by Western Rivers Conservancy in 2018 from Weyerhaeuser
- Save Nason Ridge Campaign
- Chelan-Douglas Land Trust
- Western Rivers
 Conservancy is an interim property holder



Nason Ridge Community Forest Management Plan

- 2019 Legislative proviso
- Chelan County, CDLT, RCO and local partners develop plan
- Submit to Legislature and Governor by December 1, 2019
- 2020 Supplemental Budget Request
- Plan addresses community benefits, forest health, recreation and access, and aquatic restoration



Examples of Community Benefits: Protection and Restoration

- Protect 2.5 miles of Nason Creek
- One mile of Kahler Creek
- ESA listed species spawn in this reach
- 100 acres of floodplain
- 288 acres of riparian reserve
- 429 acres deed of right restriction
- Aquatic restoration
