Entry + Access

- improvements needed for railroad crossing
- generally level topography

Waterfront

• slopes may complicate or limit space available to access the water

Upland

- existing vegetation is primarily orchard with limited native vegetation
- gradually sloping area for accessibility & recreation programming
- trail connections throughout site, to the water, and to the greater Malaga community
- open space is large enough to accommodate a variety of activities

Entry + Access

- improvements needed for railroad crossing
- sloped topography could create some challenges with accessibility and trail connections
- limited space for circulation or other connections
- restricted views into the site

Waterfront

• gently sloping shoreline allows flexibility in locating waterfront access

Upland

- existing vegetation is a mix of native vegetation & orchards
- relatively flat areas promote accessibility & offer a wide variety of options for recreation programming
- narrow size of the open space may limit some activities

PROPOSED MALAGA WATERFRONT PARK

Why a waterfront park in Malaga?

Malaga is the center of a growing community along the Columbia River south of Wenatchee. Though Malaga has miles of shorelines it lacks a waterfront park or recreation facilities.

Who is working on the plan?


The Malaga-Colockum Community Council, Chelan County, and the Chelan Public Utility District are reaching out to Malaga area residents, property owners, and businesses to find out what kinds of parks and recreation activities you like to do now, and what would like to see at a future waterfront park in Malaga. A consultant team is working on a suitability analysis to identify potential park sites, and to develop concepts, costs, and funding options.

What is the schedule?

The schedule is to spend about a year to review the Malaga waterfront, develop a suitability analysis, and develop a conceptual design on a selected site(s).




What is the Study Area?

The study focuses on reaches of the Columbia River about 9,000 feet west and east from the center of Malaga. Study sites are locations where early ideas are being tested. No sites have been selected for the park. Study Area Map **Assessor Land Use**



What have we heard so far?


