

RESOLUTION NO. 2020- 15

Re: Amending Resolution No. 2018-112 Bridge Weight Restrictions

WHEREAS, a specific resolution establishing county bridge load limits is required by RCW 36.75.270; and

WHEREAS, load rating analysis for certain county bridges indicate structural deficiency requiring a reduction in their load carrying capacities; and

WHEREAS, Resolution No. 2018-112 is being amended to reflect that there were load rating analyses performed in response to the Federal Highway Administration November 15, 2013 Memorandum to review bridge load carrying capacity for Specialized Haul Vehicles (SHV) and several bridges were found to be deficient in their capacity to carry these SHVs. The table below lists the additional structures and the allowable loads.

THEREFORE, BE IT RESOLVED that Section 8.16.010 of the Chelan County Code be updated to read the following; that the maximum weight load limit on all county bridges shall not exceed the gross weight limits for vehicles as is set forth by the laws of the State of Washington, provided, that it shall be unlawful for the operator of any vehicle to drive upon any of the bridges as is set forth and described in this chapter when the gross load limits exceeds the weight in tons as herein set forth for the various bridges described herein, as follows:
