RESOLUTION NO. 2023- 93

A RESOLUTION OF THE BOARD OF COMMISSIONERS FOR CHELAN COUNTY ADOPTING THE ADVANCED SIX-YEAR TRANSPORTATION CONSTRUCTION PROGRAM FOR 2024-2029.

WHEREAS, RCW 36.81.121 requires the preparation and annual updating of a six-year comprehensive transportation program, to be adopted by the County Commissioners prior to adoption of the annual budget, in order to assess funding availability for anticipated road and bridge construction projects and any other specified capital outlays for the following six-year period; and

WHEREAS, the Department of Public Works has prepared an Advanced Six-Year Transportation Construction Program for 2024-2029 ("Six-Year Program") for presentation and recommendation to the Board of County Commissioners; and

WHEREAS, a public hearing on the Six-Year Program was duly advertised to be held on September 26, 2023; and

WHEREAS, the Six-Year Program includes proposed road and bridge construction work and other transportation facilities and programs appropriate for and consistent with the County Comprehensive Plan and items required by RCW 36.81.121 and WAC 136-15-020; and

WHEREAS, pursuant to WAC 136-14-040 and -050, priority arrays were developed and consulted during the preparation of the Six-Year Program; and

WHEREAS, pursuant to WAC 136-20-060, the County Engineer has prepared a written report of County bridge inspection findings and the Six-Year Program utilizes the bridge report, along with county road inventory maintained and updated by the Department of Public Works, in establishing priority programming for the County; and

WHEREAS, the County Engineer's bridge report is, and has been available to the Board of County Commissioners during the preparation of this proposed Six-Year Program to aid in the development and review of said Program; and

WHEREAS, pursuant to WAC 136-15-030, the Six-Year Program includes a Financing Plan analyzing realistic revenues and expenditure;

NOW THEREFORE, BE IT RESOLVED, that:

The Six-Year Program, as prepared and recommended to the Board of County Commissioners, is hereby adopted as the Chelan County Advanced Six-Year Transportation Construction Program for 2024-2029; and

This adopted Six-Year Program supersedes all previously adopted six-year transportation programs previously adopted; and

The Board of Commissioners authorize the filing of this Chelan County Advanced Six-Year Transportation Construction Program for 2024-2029, accompanied by this adopting resolution, with the state secretary of transportation not more than thirty days after the date of adoption below and filed with the county road administration board not later than December 31, 2023; and

This Six-Year Program shall be available from the Department of Public Works to utilities in order to minimize both utility customer and road user inconvenience related to future road improvements.
