The permittee shall further hold blameless, harmless and indemnify the county, the officers, agents and employees against any accident, liability, lose, injury, seller, and the costs thereof arising from the conduct or operations of the permittee in connection with this permit. I further understand that prior to movement the permittee shall establish a route to safely detour all structures having a limited clearance less than the permitted height. If the permit is changed, I authorize billing to the firm named.

This permit is only valid for county roads within Chelan County. Additional permits may be required for operation on State and other local jurisdictional roadways.
