

## **INMATE COORESPONDENCE**

Incoming mail to an inmate will only be accepted from the U.S. postal service or other authorized commercial carriers.

Mail sent to inmates will be addressed with their full committed name. Staff will make reasonable effort to identify the inmate for whom the mail is intended.

Money orders may be sent to inmates – made payable to CCRJC with the inmate's name recorded in the memo section of the document.

Incoming mail for inmates must have a viable return address as defined by the U.S. postal service. Mail without a viable return address will be rejected and may be placed in the inmates property.

CCRJC currently provides the Wenatchee World newspaper to general population inmates.

Inmates may receive publications (periodicals, magazines, paperback books, pamphlets, provided that the publications are sent directly from the publisher or Amazon.com.

## INMATE VISITATION

All visitation for incarcerated individuals can be facilitated via video visitation.

In-person visitation will be offered only for those people who have been incarcerated for more than 30 days.

All incarcerated individuals are provided the needed tools which allow them to visit friends and family via video.

### VIDEO VISITATION

The jail will be closed for video visiting daily during these hours:

11:00 p.m. to 6:00 a.m.

*Any nudity shown by a visitor will result in the loss of visitation privileges for that visitor. Reoccurrences by the same incarcerated person may result in loss of video privileges for him/her as well. There are two computer monitors in the jail lobby to provide visitation access for people who do not have access to a computer. Lobby monitors are free, but you must complete a registration process to schedule their use.*

## IN-PERSON VISITATION

Schedule:

**Wednesday visiting, call Wednesday between 10:00 and 11:00 a.m., or until the appointment slots are full.**

**Saturday visiting, call Friday between 10:00 and 11:00 a.m., or until the appointment slots are full.**

Visitation time: Wednesday 8 pm or Saturday 2 pm.  
Visitors must arrive 20 minutes prior to visit. Visits are 50 minutes long

- **Inmates must have been incarcerated for a minimum of 30 days at CCRJC to qualify for In-person visitation.**
- **ALL adults must present photo identification at time of visit.**
- **A maximum of three (3) people may visit an Inmate per session.**
- **ALL minor children must be accompanied by an adult.**
- **ALL children that possess photo identification (example; school I.D.) are encouraged to bring, and present at time of visit.**
- **NO Loitering in hallways or common areas outside of visitation booths. ALL visitors must remain in the visitation booth during their scheduled visit. (brief restroom use is OK).**
- **All personal items are prohibited, and must be stored prior to visiting. Any violation may result in suspension from CCRJC visitation. NO SUBSTITUTIONS ARE ALLOWED**  
**Inmates are allowed only 1 visit per week (week consists of Wed & Sat).**

## INMATE MONEY – PHONE & COMMISSARY

Chelan County Regional Jail provides commissary services for the inmates incarcerated at our facility. The commissary provides the opportunity for inmates to purchase personal hygiene items, snacks, and some clothing items. Inmates pay for these items using monies deposited to their account. To put money in an inmate's account you may do so by phone, internet, through the U.S. mail or the kiosk located in the jail lobby.

Money can be applied to commissary accounts 24 hours a day by phone, internet or the kiosk located in the jail lobby.
